"Egypt: Ratifying and Lifting Reservations on International Human Rights Instruments" Cairo – Sunday & Monday, May 11–12, 2025

Summary of Outcomes and Recommendations

- 1. Establishing a central database of foreign refugees and asylum seekers in Egypt with inter-agency coordination.
- 2. Creating an independent national entity to oversee refugee affairs and ensure their rights.
- 3. Legal codification of an independent refugee agency to coordinate with national and international actors.
- 4. Reviewing procedures for withdrawing refugee status to align with international norms.
- 5. Increasing international financial and technical support to Egypt, as a major host country for refugees, and enhancing law enforcement training and translation services.
- 6. Amending Article 126 of the Penal Code to align with the UN Convention Against Torture's definition.
- 7. Enhancing police training on refugee rights and ensuring legal aid access.
- 8. Ratifying optional protocols to international treaties to strengthen oversight mechanisms.
- 9. Repealing the Terrorist Entities Law and vague security laws.
- 10. Criminalizing enforced disappearance explicitly under domestic law.
- 11. Reforming pretrial detention laws to prevent abuse and uphold the presumption of innocence.
- 12. Initiating a formal dialogue between the NCHR and the government on acceding to the OPCAT and adopting a national anti-torture plan.
- 13. Involving stakeholders in legislative development processes.

- 14. Amending laws that hinder women's equal participation.
- 15. Enacting a unified law to criminalize all forms of gender-based violence, incorporating CSO proposals.
- 16. Reviewing Egypt's reservations to CEDAW and considering interpretative declarations instead, in line with Islamic law and international equality principles.
- 17. Implementing national dialogue recommendations, especially the establishment of an independent anti-discrimination commission.
- 18. Launching educational programs for religious leaders on international conventions.
- 19. Promoting strategic litigation to drive legal reform and treaty compliance.
- 20. Reforming the Personal Status Law to ensure gender equality and reflect the civil nature of the state.
- 21. Explicitly criminalizing child marriage as a form of gender-based violence.
- 22. Clarifying the legal definition of refugee status in the draft asylum law.
- 23. Strengthening oversight of public institutions implementing women's rights laws.
- 24. Establishing a national mechanism to monitor implementation of women's rights treaties, with NCHR participation.
- 25. Initiating a societal dialogue on reviewing capital punishment.
- 26. Forming a multidisciplinary national committee to reduce capital crimes and promote alternatives.
- 27. Publishing regular official data on executions in line with UN recommendations
- 28. Develop a comprehensive national strategy for aligning national legislation with Egypt's international human rights obligations, including periodic reviews of laws and practices to ensure full compliance with ratified treaties.
- 29. Foster a structured, inclusive dialogue with civil society organizations and independent experts when preparing state reports to international treaty bodies, ensuring transparency, broad participation, and institutional cooperation
